## **Others Present**

None

- 1. Rob Hedgepeth called the meeting to order at 1902 hours. This meeting was delayed from the originally scheduled 1 AUG date to allow for more information and discussion resulting from the University of Iowa Foundation meeting held August 14.
- Rob called for any conflicts of interest; Dave Lewis again noted that he would have a conflict of
  interest when he spoke about the different accounts that the UI Foundation (UIF) and the
  Community Foundation of Johnson County (CFJC) that he is the head of. Dave said that he would
  pass along the information that he learned but would recuse himself from any votes that were taken
  to establish accounts.
- 3. Approval of the minutes for the regular board meeting of 28 JUN 2017 were unanimously approved on a motion by Diana Meador and a 2<sup>nd</sup> by Joe Poch.

# 4. Committee Reports:

- a. Finance Committee:
  - i. Treasurer's Report. Joe presented the account balance, noting that it has increased by a \$50 donation since last presented for a current balance of \$2,363.25. Motion to approve the treasurer's report by Katie Hanna, 2<sup>nd</sup> by Brad Cook. Motion was unanimously approved.
  - ii. Dave Lewis and Luke Peters met with UI Foundation (UIF) representatives Javier Perez and an understudy of Jeff Lieberman to discuss funds further. They continued to be unable to address how the MHBAA might be able to influence distribution of funds from accounts that MHBAA actively provides outreach to our membership to solicit donations.

- iii. Dave also related that Javier said the UIF has established an Army ROTC Facilities Fund and a Army ROTC Program fund. A search of the UIF website after the meeting led to these fund: <u>https://www.givetoiowa.org/armyrotc</u>
- iv. Javier stated that the foundation could not host an operational account, that the foundation accounts had to conform to 501(c)(3) rules and could not raise funds on a tax exempt basis for food, alcohol, etc. Hedgepeth stated that this was the genesis of the account originally established with the Uofl Alumni Association (UIAA). The disposition of this account remains in question as UIF and UIAA continue to work through the details of their merger.
- v. Stewart Wallace made a motion to "Direct the Treasurer to establish an operational account that will not offer contributors any tax benefit, at an Iowa City area bank or credit union, with the account to be used as directed by the board for the benefit of the MHBAA." The money currently existing in the UIAA account will be used to establish this account. Motion was seconded by Jeff Borland and approved by all voting members (with Dave Lewis abstaining).
- vi. Discussion of the establishment of a fourth account to take advantage of Iowa Tax Credits for donors was tabled for the moment. The "Fund our Opportunities" committee will continue to explore.
- vii. Katie Hanna also asked for additional information so that the three new funds and their purposes can be communicated and advertised to the membership. She also asked about the MHBAA information on the <a href="http://iowalum.com/mightyhawkeye/">http://iowalum.com/mightyhawkeye/</a> website. Hedgepeth to ask Luke Peters to explore.
- b. Strategic Vision Committee: Update on committee progress Brad Cook
  - i. <u>Build a World Class Network of Leaders</u>: Brad sent an email to board members on 7/9/17 with information related to mentoring opportunities. He will present summary at the next meeting. Board members are asked to provide feedback to Brad.
  - ii. <u>Support & Enhance Department Activities</u>: Jeff Borland conducted a teleconference with this committee. They are discussing fundraising events that MHBAA can assist with, such as the Bataan Death March, or other military related events. They are also discussing possible fundraising events.
  - iii. <u>Recruit the Next Generation of Leaders</u>: Stewart Wallace mentioned that Tony Wolf has 38 freshmen interested with 2 already on scholarship.
  - iv. <u>Promote our Organization</u>: Melanie Young and Eli Seeley are heading this and looking for a couple of more members. No Update.
  - v. <u>Fund our Opportunities</u>: See discussion above related to Community Foundation exploration and advertisement of new accounts.
